Due to changing processes and increased administrative costs many NICET fees are changing. These changes include separate pricing for testing and certification applications for the Standard Model/CBT. Please see the list below for fee changes and effective dates.

Students:	\$105*

Testing Expediting Fee:	\$100 (to fill empty seats after application deadline)
Test Rescheduling Fee:	\$125 (per Policy 24)
Hand Scoring Fee:	\$100

Certification Application (effective 9/1/2010)	
Technician Level I only:	\$100 (Includes 3 evaluations of supplemental materials for first year)
Individual or Multi-Level:	\$150 (Level II or higher. Includes 3 evaluations of supplemental materials for first year)
Reciprocity, A/B & Technologist:	\$150 (Includes 3 evaluations of supplemental materials for first year)

Other Evaluation Fees (effective 7/1/2010)	
Supplemental Materials Evaluation:	\$25/submittal (Evaluation of supplemental materials after third submittal or first year)
Re-Evaluation Fee:	\$100 (Re-evaluation of all approved materials after 3 years)
Evaluation Expediting Fee:	\$100 (Perform evaluation within five working days of receipt)

Practice Tests (effective upon implementation)	
Practice Questions	Priced approximately \$1/question

Recertification (effective with 2011 expiration dates)*	
Base Fee:	\$40/year – collected as \$120 every 3 years
Each Certification:	\$15/year – collected as \$45 every 3 years
Retired Status:	\$15/year – collected as \$45 every 3 years
Inactive Status:	\$25/year – collected as \$75 every 3 years
Reactivation:	\$75
Reinstatement:	\$150 (plus “recertification” exam fee, evaluation fee & annual certification fee)

*Continue to recertify with CPD every 3 years

Non-Certification Records Maintenance (i.e. NJ-DCA) (effective with 2011 expires)	
Initial Registration:	\$75
Records Maintenance:	\$55/year – collected as \$165 every 3 years

Bad Check Service Charge (effective 7/1/2010)	
Bad Check	\$65 each

Very Small Subfield (less than 100 certificant):	\$10
Small Subfield (101 - 1,000 certificant):	\$20
